- Sub: Web based TamilNilam – Unblocking of lands that have been covered under ULC/ULT – sending workflow and instructions to the districts for processing these applications – reg.
- Ref: 1. This office email K8/3774/2014, dtd: 08.11.2016 (Bilingual user manual on A-Register Addition / Correction / Deletion Modules)  
2. This office letter Rc.K8/9295/2019, dtd: 19.10.2020 addressed to the Additional Chief Secretary to Government / Commissioner of Urban Land Ceiling / Urban Land Tax, Chennai.

I invite kind attention to the references cited.

Currently, the lands that are covered under Urban Land Ceiling and Urban Land Tax (ULC/ULT) have been marked as அரசுபஞ்சை (அபஞ்சை) or அரசுநஞ்சை (அநஞ்சை) in online land records with remarks mentioned as 'உபரிநிலம்' (or) தமிழக அரசு. However, in some districts it was observed that lands covered under ULC/ULT have been marked as அரசுபறம்போக்கு (அபறம்போக்கு).

Requests have been received from the public (innocent buyers) for unblocking the lands carried under ULC/ULT after getting proper Government Order or letter.

Accordingly, during the month of October 2020, NIC has developed a software module for unblocking of ULC/ULT lands based on the request sent from this directorate and it was deployed in all Rural online Taluks.

However, as it was mentioned earlier, in some districts the lands covered under ULC/ULT have been marked as அபறம்போக்கு. The unblocking module displays only the survey number / subdivision that are being mentioned as அபஞ்சை (or) அநஞ்சை in TamilNilam database.

The comprehensive step by step instructions for unblocking of ULC/ULT lands that are mentioned as (i) அபுஞ் (or) அநஞ் (ii) அபுற have been mentioned below:

**If the land to be unblocked is mentioned as Government Poramboke (அபுற):**

If the ULC land is mentioned as அபுற in online TamilNilam A-reg the steps to be followed as follows:

Any A-reg corrections in respect of unblocking of ULC/ULT lands that has been mentioned as “அபுற” should be done at the level of District Collector and should be first corrected as அபுஞ் (or) அநஞ், after thoroughly examining the original classification by referring to the UDR (printed) A-register. The records must be scrupulously verified and ensured that only the survey number / sub-divisions that have been covered under ULC/ULT but it has been wrongly mentioned as அபுற should alone be changed as அபுஞ் (or) அநஞ்.

**Workflow for changing from அபுற to அநஞ் :**

Patta Assistant → Firka Surveyor → Zonal Deputy Tahsildar → Tahsildar → Revenue Divisional Officer / Sub-Collector → District Collector (Digital signature).

If the Survey number / sub-divisions that needs to be unblocked from ULC/ULT has been mentioned as அரசுபுஞ்சை (or) அரசுநஞ்சை (or) அரசுமாவாணி the work flow is mentioned as follows:

**Unblocking of ULC/ULT - Not Involving Sub Division:**

Patta Assistant → Zonal Deputy Tahsildar → Tahsildar

**Unblocking of ULC/ULT - Involving Sub Division:**

Patta Assistant → Maintenance Firka Surveyor → Land Record Draftsman → Deputy Inspector of Survey → Tahsildar.

Therefore, I request you to communicate this instruction down the line to all the Taluk and RDO offices for carrying out transactions in respect of unblocking of ULC/ULT lands.
